#### 2017 ANNUAL REPORT

#### Prepared for ACHRE AGM held on Monday, 13 November 2017

Thanks to the tireless work of the ACHRE Patrons, Advisory Committee, Committee of Management and individual members, the year 2017 was very successful for human rights education in Australia; much was achieved and ACHRE is in a stronger position to focus on our tasks in 2018.

Below is a short summary of key activities.

#### INTERNATIONAL HUMAN RIGHTS EDUCATION CONFERENCES

Over past years, the IHRE conference series has explored various facets of Human Rights Education worldwide. The inaugural IHRE Conference, 'Educating for Human Rights, Peace and Intercultural Dialogue' was hosted by the University of Western Sydney in 2010 with successive annual conferences hosted by the University Kwazulu-Natal in Durban, South Africa; Jagiellonian University in Cracow, Poland; Soochow University, Taipei, Taiwan, the American University, Washington DC, United States of America, and recently the University of Chile in Santiago de Chile.

The <u>International Human Rights Education (IHRE) Conferences</u> will continue to provide a forum for the exchange of ideas and information and facilitate open discussion on human rights education amongst participants. Participation in these conferences will allow students and academics alike, as well as members of the civil society community, to share their views and to gain insights from their fellow participants.

Human rights education is about societal standards that need to be learned by each generation and transferred to the next. Thus, at the conferences, world class experts focus on the contribution of a human rights culture to the good functioning of civil society and highlight key trends and achievements in human rights education across the world. They explore philosophical questions and more pragmatic aspects such as how, what and when to apply human rights education methodologies. The conferences include practical hands-on workshops so that participants walk away with transferable human rights education skills and knowledge.

The 7<sup>th</sup> International Human Rights Education Conference 'Addressing the Challenges of the Civil Society' was held at the Human Rights Centre, Faculty of Law (Centro de Derechos Humanos, Facultad de Derecho) at the University of Chile between 12-15 December 2016. The first of these Conferences to be held in Latin America, it was organized by the Faculty of Law's Centre for Human Rights and its Office of Outreach, in cooperation with ACHRE and Western Sydney University. The Organizing Committee included representatives from both the University of Chile and Western Sydney University as well as ACHRE. From the University of Chile: Lea Newfarmer, Myrna Villegas, Alex Choquemamani, Paulina Pulido, Natalia Reyes, Lorena Pino, Camila Araneda, Claudia Cárdenas, Javier Godoy, Nicolas Bosbach, and Sebastián Candia. From Western Sydney University and ACHR: Sev Ozdowski. The conference was attended by 185 people from 25 countries.

The conference structure included 12 panel presentations, introduced by specially invited speakers, such as Claudio Grossman, Dean of the Washington School of Law, American University in Washington, DC, and Professor Sev Ozdowski, Director Equity and Diversity, Western Sydney University in Sydney, Australia and

AHREC founder. Each panel was moderated by local Chilean human rights professionals, such as Dania Maquilón, Sub-secretary of Human Rights, Chilean Ministry of Justice, and Myrna Villegas, Human Rights Centre, Faculty of Law, University of Chile. Panel topics covered a wide span of themes, such as: "Gender and HRE," "Multiculturalism and Human Rights Education," "Global Tendencies and Local Experiences in HRE: Memory Sites, Urban Spaces, and the Role of the State," and "HRE in Formal Educational Systems." In addition, poster sessions were held simultaneously with the panels.

# **ACHRE KEY PROJECTS**

#### Symposia, conferences and seminars

• The 7th International Human Rights Education Conference
ACHRE President Dr Sev Ozdowski participated in the 7th International Human Rights Education
Conference held in Chile from 30 November - 3 December 2016 where he delivered opening and closing remarks, a speech on "HRE in Multicultural Society" and chaired a number of sessions.

#### • ACHRE's Support for Australia's bid for the UN Human Rights Council

ACHRE strongly supported Australia's candidature for a seat on the United Nations Human Rights Council for the term 2018-20. Ms Pera Wells, Vice-President of ACHRE participated in a panel discussion on 11 April 2017, convened by the Human Rights Law Centre, on Australia's bid for a seat on the UN Human Rights Council. The ACHRE has joined several civil society organisations to call on the government to improve the quality of its voluntary pledges.

# • Anti-racism Agreement with ACHRE

ACHRE continues to work with the Australian Human Rights Commission to support the Commission's 'RACISM. IT STOPS WITH ME.' Campaign. ACHRE cooperation agreement with AHRC will expire in 2019.

#### • UNESCO Project

Prof Joseph Zajda, ACHRE Treasurer participates in the UNESCO Governance in Education (BRICS countries) project.

#### • ACHRE Supporting Regional Human Rights Education

ACHRE sponsored the provision of fifty Citizen for Humanity certificates to graduates in The Women Peace and Leadership (WPL) Program. WPL Program is an initiative of the Institute for Peace and Conflict Studies at the National University of Timor Leste (UNTL). In the words of participants: "[We are] so happy to have this certificate, thank you ACHRE".

#### 9-02-2017 - DFAT Consultation on Human Rights with NGOs

The event attracted representatives of NGOs from all over Australia, including a significant number of Aboriginal people.

# The Citizen for Humanity Project - South Australia

ACHRE provided financial assistance and operational support to the Brighton Primary School in Adelaide to undertake the following projects.

#### • The Brighton Secondary School in South Australia

The school undertook the Citizens for Humanity Project with all Year 9 students (over 300). The project objective was to broaden students' understanding of human rights through their engagement with local communities across Adelaide. The project was concluded with all the Year 9 students taking part in a formal ceremony at which Dr Sev Ozdowski AM, the ACHRE President, awarded "Citizens for Humanity" certificates to each of the Year 9 classes. The school ceremony celebrated the diversity of student work and achievements together with some guests from local communities and parents.

# **ACHRE ADMINISTRATION & SECRETARIAT**

- The Australian Council for Human Rights Education Inc. (ABN 21 396 291 313) has been registered by the
  Australian Charities and Not-for-profits Commission as a charity with the subtypes of advancing education,
  promoting reconciliation, mutual respect and tolerance between groups of individuals that are in Australia,
  as well as promoting or protecting human rights. The effective date of registration is 3 December 2012.
- ACHRE Public Officer Dr Madeleine Laming contacted the Australian Business Register to arrange for the ABR record to be amended to correctly reflect the fact that the ACHRE has been changed from NCHRE and that ACHRE holds ABN number 21 396 291 313.
- The Administration work in support of the Management Committee has continued relatively smoothly. The
  electronic filing system has been kept up to date which includes all agendas, minutes and correspondence
  throughout the year. As the teleconferencing with Skype has presented significant connectivity issues,
  ACHRC moved its teleconferences to ZOOM system.
- ACHRE Treasurer Associate Professor Joseph Zajda reported that the balances on 13 November on the Australian Human Rights Education Fund Account Term Deposit of \$23,453 CR and on the ACHRE Inc. Account #10496627 is \$1,506.16 CR. In 2016 ACHRE has secured \$1,500.00 in donations.

The Treasurer Zajda has informed ACHRE that he will not nominate for the position of Treasurer for 2018. It is my privilege to have worked with Professor Zajda for last 12 years and I wish to put on public record my gratitude for his achievements as ACHRE Treasurer over this time. Thank you, Joseph.
